Trafficking and Domestic Violence Issues Hotline for U Visas and VAWA Petitions - (303) 866-9396.

- CLS assists victims of human trafficking to report their crime and to apply for temporary and long-term immigration relief. CLS also provides information and legal assistance to individuals wishing to sue their traffickers for lost wages and damages as a result of the trafficking.
- Human trafficking is a form of modern day slavery. Victims are often lured into forced labor and/or sexual exploitation by false promises, force or threats of harm to themselves and their families. Signs of a potential trafficking situation include the confiscation of identity or immigration documents, physical confinement, threats and/or acts of harm against a person or his or her family, debt bondage or involuntary servitude in a legal or illegal work setting.
- Victims of trafficking may be eligible for immigration relief such as the U or T Visa. T

Immigration/Migrant Workers Issues

Visa holders receive special Immigration status for 4 years that allows the visa holder to live and work lawfully within the United States. T Visa holders are also eligible for public benefits and social services to the extent of a refugee. Depending on the age and situation of the T Visa applicant, qualified family members are eligible to be included.
